# **Lake Committee Review:** Mike Piacentino

- Moving forward on assessing the cost and benefit of the liner repairs.
  - talking to companies for generate a report / cost estimate
- Request engineering map of the Lake Jeff Simek to send an email to Julie Gonzales
  Julie reviewed her files and does not have any plats. She will reach out to Todd to see if he has
  any he can provide. I will let you know as soon as he responds.
- Areas that need rocks need to get a schedule Mike P. will have something by June Board meeting.
- Need to encourage people to stay off of the liner because of safety and more damage to liner.
- Pumps are working
- Fountains may need to be replaced. Recommendation to have the run all the time. ~cost of new fountains is \$4K. Will further assess functionality of each pump.
- Other Lake Committee suggestions include:
  - Kayak launch off of the dock near the Pavilion.
  - Put in a doggie bag station near the Pavilion.
  - o Recommend to present to the Town Hall Meeting in June.
  - Keep water level below edge of liner
  - o Continue erosion mitigation
  - Consider auto-fill mechanism for lake inflow water pumps

- Related to the "is a van a van or an RV" how do other communities you serve make that distinction with vehicles that can be used as either a passenger van or an RV? If the body of the camper, such as in Lee's photo looks like a van, it's a van. Anything larger is usually categorized as a Travel Trailer (hitched camper), Pop-Up, A Motorcoach Class A, Class B, and Class C which are all RV's. As far as the registration is concerned, it most likely does not state van.

Any experience to share on that? I emailed the insurance agent for a response.
